Redetermination deadline is April 30, 2024

Once again, Medicaid members must recertify their eligibility (redetermination), or these patients are at risk of losing their Medicaid coverage on **April 30**th.

Florida Medicaid members should be on the lookout for a redetermination letter in a yellow striped envelope in the mail from Florida's DCF. To ensure that members receive this critical piece of mail, they should validate that their address, email, and phone number are up to date in their MyACCESS account with DCF by visiting <u>https://www.myflfamilies.com/services/public-</u> assistance.

A list of your patients that must recertify **By 4/30/24 is available on** the **Redetermination Report** in NaviNet. Thank you for your support in contacting these patients to remind them of the importance of completing the necessary steps to keep their Medicaid coverage.
